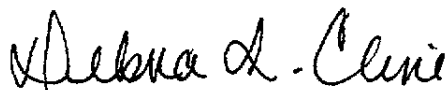

Amendment of Articles of Organization

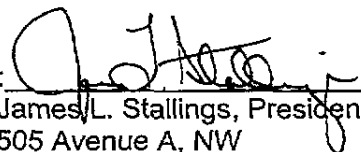

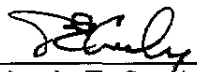
ARTICLE VIII

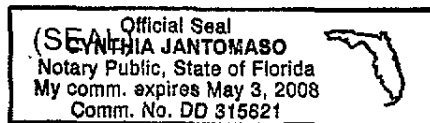
