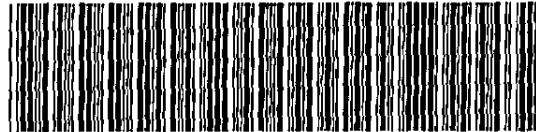

ARTICLES OF ORGANIZATION

FOR

SHADY OAKS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - Name

The name of this limited liability company shall be SHADY OAKS, LLC.

ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

ARTICLE III - Purpose and Powers

Except as restricted by these Articles of Organization, this limited liability company is organized for real estate development purposes and each and every other legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.

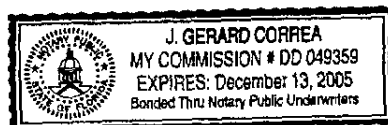


