ARTICLES OF ORGANIZATION

ARTICLE I
NAME


ARTICLE XVIII

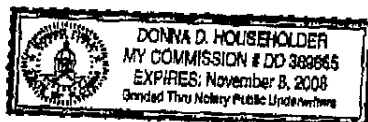
