**Amended and Restated
Articles of Organization
of
LEDEX, LLC**

The undersigned, in his capacity as a member of LEDEX, LLC, a Florida limited liability company being renamed hereby as Ledex, LLC (the "Company"), has executed these Amended and Restated Articles of Organization ("these Restated Articles"), as adopted by the Company on November 2, 2005, pursuant to a resolution contained in a written consent to action adopted by members of the Company holding a majority of the outstanding interests in the Company. Such vote of the members by written consent was sufficient for such approval.

These Restated Articles amend, restate and supersede in the entirety the Company's Articles of Organization electronically filed with the Florida Secretary of State on April 27, 2005 (the "Initial Articles"), but effective as of April 22, 2005.

These Restated Articles are adopted in order to (i) clarify the name of the Company as Ledex, LLC, rather than LEDEX, LLC; (ii) change both the Company's street address of its principal office and its mailing address; (iii) change the registered agent and registered office of the Company; (iv) make a change in the designated manager members of the Company; and (v) provide in a single document, for convenient reference, the Company's complete current articles of organization, that includes the aforesaid changes in the Initial Articles.

ARTICLE I

The name of the Company is Ledex, LLC.

ARTICLE II

The street address of the principal office of the Company and the mailing address of the Company both are:
