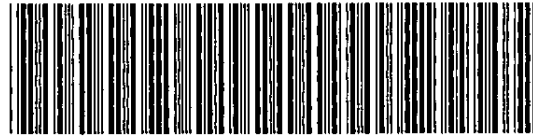

Article V shall be deleted in its entirety and replaced with the following:


