ARTICLES OF ORGANIZATION

OF

Banyan Data, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The name of the limited liability company is Banyan Data, LLC (hereinafter referred to as the "Company").

2. Period of Duration.
