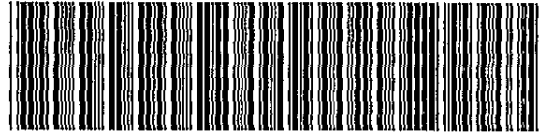

ARTICLES OF ORGANIZATION
OF
NAMCO AVIATION, LLC

Pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes (2000), as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

ARTICLE I
NAME

The name of this limited liability company (the "Company") shall be NAMCO Aviation, LLC. The Company shall engage in or transact all lawful activities and business permitted by the Act and under the laws of the State of Florida. The Company shall own aircraft which shall be operated under the Federal Aviation Administration, Department of Transportation's "General Operating and Flight Rules," Federal Aviation Regulations ("FAR"), Part 91.

ARTICLE II
ADDRESS

The mailing address and the street address of the principal office of this Company shall be 9471 Baymeadows Road, Suite 106, Jacksonville, FL 32256.

ARTICLE III
REGISTERED AGENT

The initial registered office of this Company shall be 9471 Baymeadows Road, Suite 106, Jacksonville, Florida 32256 and its initial registered agent at such office shall be Raymond Chase.

ARTICLE IV
ADDITIONAL MEMBERS

Additional members (as the term "member" is defined in Sec. 608.402(21) of the Act) may be admitted at such times and on such terms and conditions as provided in the Operating Agreement.

ARTICLE V
MANAGEMENT OF THE COMPANY

This Company will be a member-managed company managed in accordance with and subject to the requirements of the Act and the Operating Agreement of the Company. The Operating Agreement may contain any provisions for the regulation and management of the offices of the Company not inconsistent with law or these Articles of Organization.

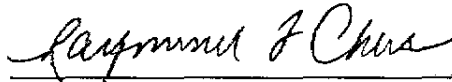
