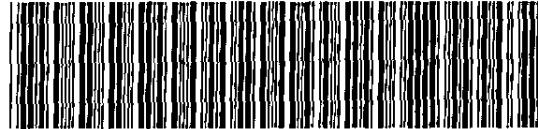

The Company is to be managed by the manager and the name and address of the initial manager is:


