# AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR

### SHINO BAY COSMETIC DERMATOLOGY & LASER INSTITUTE, LI

The Articles of Organization for SHINO BAY COSMETIC DERMATOLOGY & LASER INSTITUTE, LLC, which Articles of Organization were originally filed on April 25, 2005, are being amended and restated, in their entirety, to provide, among other things: (i) provide for the issuance of 10,000 Units of membership interest, which units shall evidence the interest of the Members of the Limited Liability Company; (ii) provide that the Limited Liability Company shall be managed by a board of managers; and (iii) provide for the Managers of the Limited Liability Company to hold offices and to have those responsibilities accorded to them by the members of the Limited Liability Company, as set forth in the Regulations of the Limited Liability Company. This Amended and Restated Articles of Organization was adopted by written consent of all of the Members and Managers of the Limited Liability Company, entitled to vote thereon, pursuant to Florida Limited Liability Company Act Section 608.411, on June 17, 2010. These Amended and Restated Articles of Organization are being filed in accordance with Florida Limited Liability Company Act Section 608.411.

#### **ARTICLE I - NAME**

The name of the Limited Liability Company is SHINO BAY COSMETIC DERMATOLOGY & LASER INSTITUTE, LLC.

#### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company is 350 E. Las Olas Boulevard, Fort Lauderdale, FL 33301.

#### **ARTICLE III - DURATION**

The period of duration for the Limited Liability Company shall be perpetual.

#### **ARTICLE IV - MEMBER UNITS**

The Limited Liability Company is authorized to issue 10,000 Units of membership interest, which Units shall evidence the interest of the members of the Limited Liability Company, which Units shall be designated "Member Units." The interest of the members of the Limited Liability Company shall be evidenced by the Certificate of Limited Liability Company Units issued by the Limited Liability Company and setting forth the number of Member Units issued and outstanding in the name of such member.
