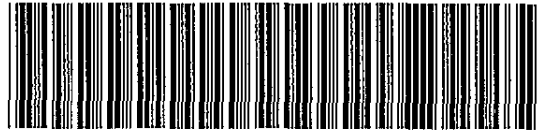


Article 3 - This dissolution has resulted in response to the **written consent** of all members to dissolve.
