**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
CLOUDTEAM, L.L.C.**

The undersigned authorized representative of **cloudteam, L.L.C.**, a limited liability company organized and existing under the laws of the State of Florida (the "**Company**"), whose Articles of Organization were originally filed with the Florida Department of State on April 29, 2005, Document Number L05000042280, as previously amended on November 4, 2013, hereby adopts the following Amended and Restated Articles of Organization of the Company:

**ARTICLE I**

**Name**

The name of this limited liability company (the "**Company**") shall be:

**ARTICLE II**

**Principal Office and Mailing Address**

**ARTICLE III**

**Registered Office and Registered Agent**

The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

**ARTICLE IV**

**ARTICLE V**  
**Operating Agreement**

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. The Operating Agreement of the Company shall be for the governance of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles of Organization or contrary to the laws of the State of Florida or of the United States.

**ARTICLE VI**  
**Duration and Continuation**

The duration of the Company commenced upon filing of the Articles of Organization. The Company shall have perpetual existence. The death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event that terminates the continued membership of a Member will not cause dissolution of the Company, and the remaining Member(s), if any, have the right to continue the business of the Company, subject to the provisions of applicable law, these Articles and the operating agreement of the Company.

**ARTICLE VII**  
**Amendment of Articles of Organization**

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Amended and Restated Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
