ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company funder the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME
