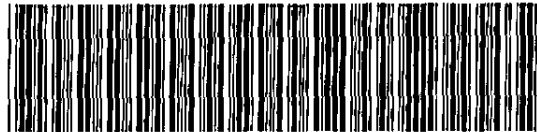

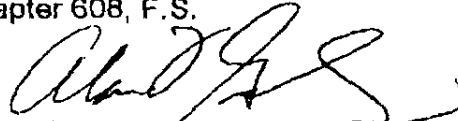

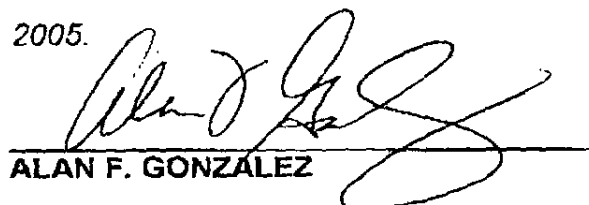
ARTICLE VI – AMENDMENT TO ARTICLES OF ORGANIZATION
