Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the Authorized Representative of STOCKWELL PROPERTIES, LLC, hereinafter referred to as the "Company," did authorize on May 11, 2005, to amend and restate the Articles of Organization in their entirety. The following Articles of Organization were adopted "the company" and are amended in their entirety as follows:

**ARTICLE I
