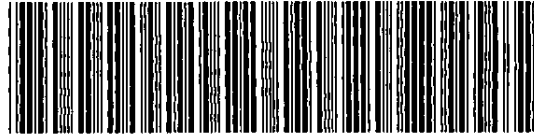

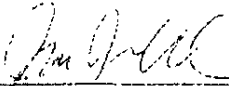

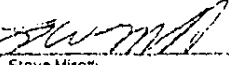
1. The name of the limited liability company is: Patriot Capital Holdings, LLC

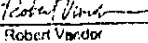
