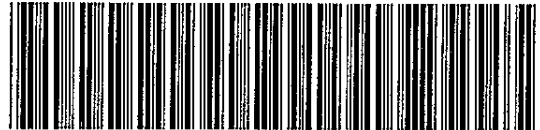

**ARTICLE I

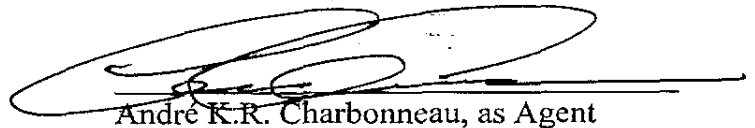

portion of, or otherwise affect the interpretation of, the Operating Agreement of the Company, as amended and in existence from time to time.

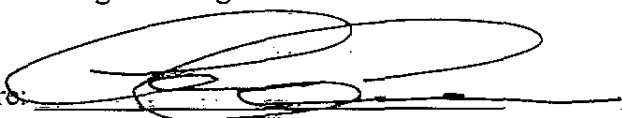
