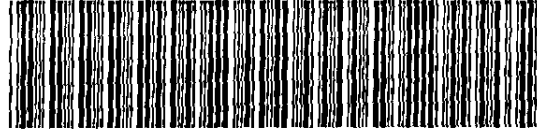

ARTICLES OF ORGANIZATION

OF

LEVERETT FAMILY HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

Article I - Name

The name of the limited liability company shall be **LEVERETT FAMILY HOLDINGS, LLC** ("Company").

Article II - Principal Place of Business and Address

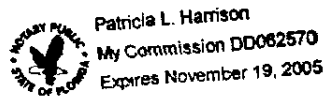

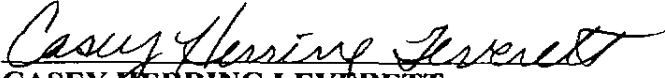
