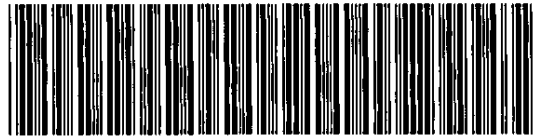

CHANGE OF REGISTERED AGENT/REGISTERED OFFICE:


Mercedes Izquierdo is hereby deleted as the Registered Agent of the corporation.
