The Company shall be a manager-managed Company, and the initial Manager is Gerald Mills.

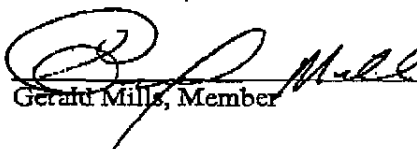
**ARTICLE V - PURPOSE**
