PLAN OF MERGER OF IGH ROOKS, LLC, IGH OVO, LLC, AND BAY MOUNTAIN HOLDINGS, LLC, WITH AND INTO IGH 1501 MAIN, LLC

IGH Rooks, LLC, a Florida manager-managed limited liability company, IGH Ouc, LLC, a Florida manager-managed limited liability company, Bay Mountain Holdings, LLC, a Florida manager-managed limited liability company, and IGH 1501 Main, LLC, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 608.438, Florida Statutes. The terms of the plan are as follows:

- 1. The names of the business entities planning to merge are IGH Rooks, LLC, a Florida manager-managed limited liability company ("Rooks"), IGH Ovo, LLC, a Florida manager-managed limited liability company ("Ovo"). Bay Mountain Holdings, LLC, a Florida manager-managed limited liability company ("Bay Mountain"), and IGH 1501 Main, LLC, a Florida manager-managed limited liability company ("1501 Main").
