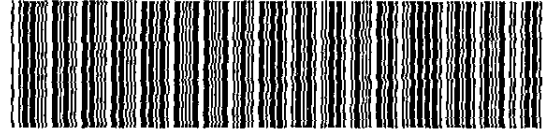

SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:


For the purpose of changing the initial manager of the limited liability company, Article VII is hereby amended as follows:
