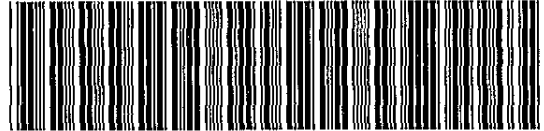

(Pursuant to Chapter 608, Florida Statutes)


1. **Name.** The name of the limited liability company is CORAL REEF CREAMERY, LLC.
