### ARTICLES OF ORGANIZATION for White Trash-101, LLC

**THE UNDERSIGNED**, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles or Organization for such company:
