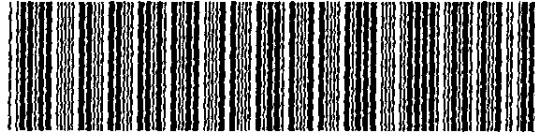

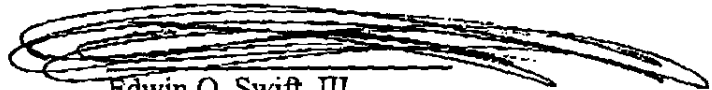

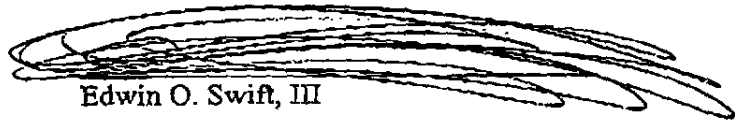
ARTICLE IV
