**ARTICLE VII - TERMINATION OF EXISTENCE**



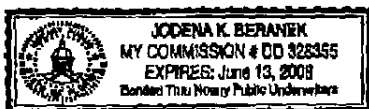
