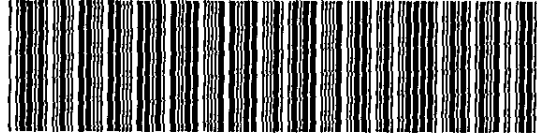

ARTICLE 1: NAME

The name of the limited liability company (the "Company") shall be Streamline Bracing, LLC.

ARTICLE 2: PURPOSE

The company may admit any additional members upon the member becoming a party to the operating agreement or similar agreement among members then in effect.

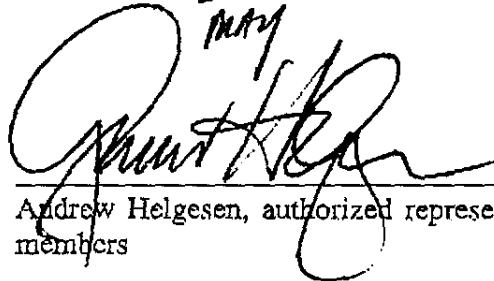
ARTICLE 10: AMENDMENT

The company has the authority and may issue Certificates of Membership to each member evidencing that member's interest in the company. Certificates of Membership shall be signed by a manager of the company.

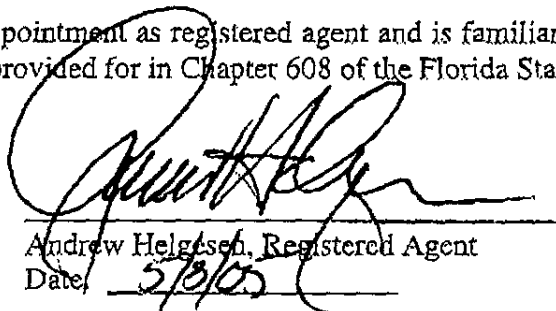
