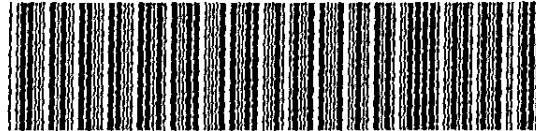

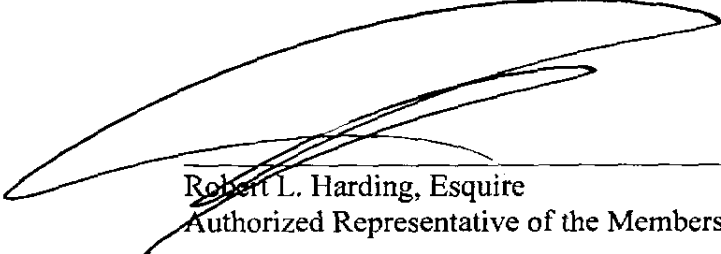
**ARTICLE V - Registered Agent and Office**

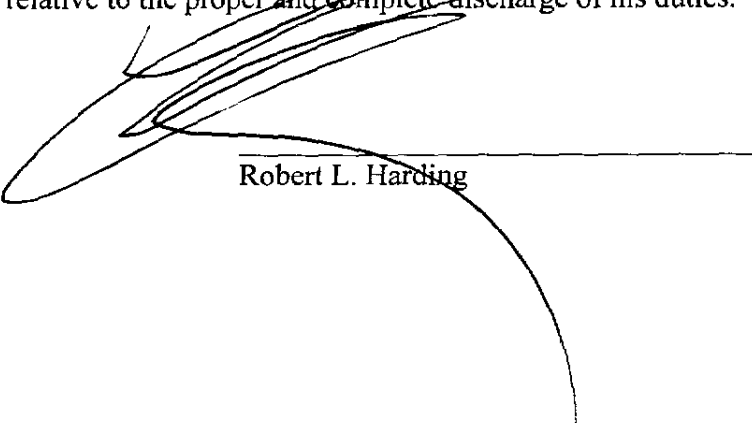
