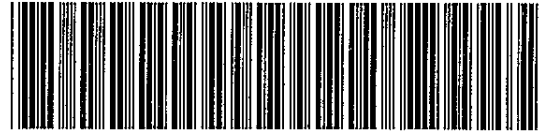




ARTICLE VI JUSAJA, L.L.C. is a manager- managed limited liability company with the day to day control vested with JAY THOMAS HUFFMAN.
