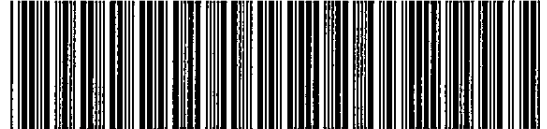

**ARTICLES OF ORGANIZATION OF**

**CURIOUS G., LLC**

**ARTICLE I**

**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be CURIOUS G., LLC, and the mailing address and street address of its principal office shall be 20020 Veterans Blvd, Unit 11, Port Charlotte, FL 33954, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II**

##### **MEMBERSHIP RESTRICTIONS**

These Articles may be amended by a vote of a majority in interest of the members.


#### **ARTICLE VII**
