ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION

Article I of the Articles of Organization filed on May 5, 2005, is amended as follows:

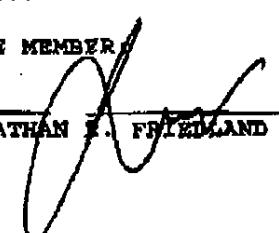
"ARTICLE I
