The name of the Limited Liability Company is RAW DAWG ENTERTAINMENT LLC.

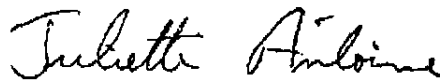
ARTICLE II - ADDRESS
