ARTICLES OF ORGANIZATION **OF**

HILLSBOROUGH HAVENS, LLC

THE SERVICE CORPORATION OF THE PROPERTY OF THE The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be HILLSBOROUGH HAVENS, LLC.

ARTICLE II - ADDRESS


ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS
