

ARTICLES OF ORGANIZATION

OF

- CECUMASSES PROPERTY. Name. The name of this limited liability company is Ranger 40, LLC Florida limited liability company (the "Company").
- Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
