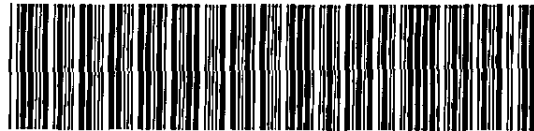





**ARTICLE VI – INDEMNIFICATION**
