ARTICLES OF ORGANIZATION SCM INVESTMENTS, LLC

SHA SHIDE The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is SCM INVESTMENTS, LLC (hereinafter referred to as the "Company").

2. PERIOD OF DURATION.

The period of duration of the Company shall be from the date of filing of its Articles of Organization until the first to occur of the following:

- Dissolution of the Company pursuant to the provisions of the Florida Limited (i) Liability Act; or
- As provided for in any written Operating Agreement among the Members. (ii)

3. PURPOSE.

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

4. ADDRESS OF PLACE OF BUSINESS.

5. REGISTERED AGENT.

The initial registered agent in Florida for the Company is Scott C. Maddox, and the initial registered office is located at 501 North Duval Street, Tallahassee, Florida 32301.

6. MEMBERS.

The Company shall have at least one (1) Member, and may admit additional members upon

the prior unanimous written agreement of the then existing Members, or as otherwise provided in the Operating

Agreement.

7. CONTINUITY OF BUSINESS.

If the Company has more than one (1) Member, then upon the death, retirement, resignation,

expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the

continued membership of a Member in the Company, the business of the Company shall be continued and the

Company shall not be dissolved without the prior written consent of all the remaining Members (if any) of the

Company.

8. MANAGEMENT.

The management of the Company shall be reserved to its Members. The Members may, from

time to time, elect a manager in the manner provided in any written Operating Agreement among all of the

Members. Any such Manager shall have the powers and authority expressly granted under the Operating

Agreement.

9. **INDEMNIFICATION.**

Except as expressly provided otherwise in the Operating Agreement, the Company shall

indemnify any Member or former Member to the full extent permitted under the Florida Limited Liability

Company Act.
