

The undersigned, desiring to form a limited liability company under the provisions of Section 608.401 Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I Name. The name of the Limited Liability company is TOWN & COUNTRY GROUP, LLC.

Article II Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 10380 U.S. HWY 19 No., Pinellas Park, FL 33782

Article III Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of Pinellas Park, at 10380 U.S. HWY 19 No. Pinellas Park, FL 33782. The initial registered agent is Jennifer Merritt, whose business address is the same as the post office address of the initial registered office, and who is a resident of Florida.

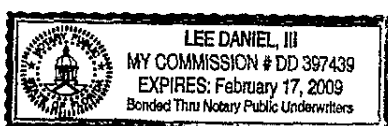


