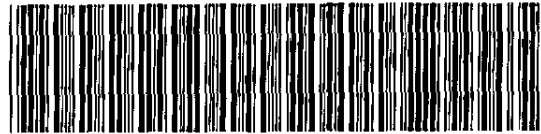

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **HEALTH & WEALTH, LLC** ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1370 South Ocean Boulevard, Lantana, Florida 33462 and the mailing address shall be the same.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

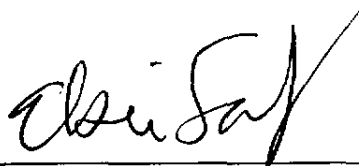
