

#### ARTICLES OF ORGANIZATION

#### OF OCEANS 11, L.L.C.

I, the undersigned subscriber to these Articles of Organization, being a natural person competent to contract, hereby execute this document for the purpose of becoming a limited liability company under the laws of the State of Florida.

#### ARTICLE I: NAME

The name of this limited liability company shall be:

OCEANS 11, L.L.C.

#### ARTICLE II: BUSINESS AND MAILING ADDRESS

The principal place of business of this limited liability company shall be 9122 Seafair Lane, Tallahassee, FL 32311, but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world.
