ARTICLES OF ORGANIZATION

of SUPPORT 100 CONSTRUCTION, LLC
A Florida Limited Liability Company

1. Name: The name of the limited liability company is SUPPORT 100 CONSTRUCTION, LLC (sometimes hereinafter referred to as the "LLC").

2. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

3. Address of Principal Office: The address of the registered office of the limited liability company is 4975 Pinewood Place, Cocoa, Florida 32926; mailing address: 4975 Pinewood Place, Cocoa, Florida 32926. The registered agent at that address is Wallace R. Cook, 4975 Pinewood Place, Cocoa, Florida 32926.

4. Members at Time of Formation: The initial members are Judith A. Cook.

5. Period of Duration: The period of duration of this LLC shall be perpetual.

6. Management: Management of the LLC at the time of formation is: Wallace R.. Cook, 4975 Pinewood Place, Cocoa, Florida 32926.

7. Admission of New Members: With the written unanimous consent of the existing members, new members may be admitted into the LLC from time to time upon the payment of such capital contributions and upon such terms as the then existing members unanimously decide. In the event that new members are admitted into the LLC, the share of each new member in the profits and losses shall be in such proportion as may be agreed upon amount all of the existing members and the new member or members.

8. 



11. Regulations (Operating Agreement): Any Regulations (as defined in Section §608.402 (24) of the Act), relating to this Limited Liability Company must be in writing and signed by all of the Members.


