ARTICLES OF ORGANIZATION OF GRAHAM GROVES DEVELOPMENT, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608, i.e. the "Act".

- 8. <u>Management of the Company</u>. The Limited Liability Company is to be managed by its members or elected managing member or members and is, therefore, a member-managed
