## **ARTICLES OF ORGANIZATION**

### **OF A.P. VENTURE, L.L.C.**

This limited liability company shall have perpetual existence, unless sooner voluntarily dissolved according to law.

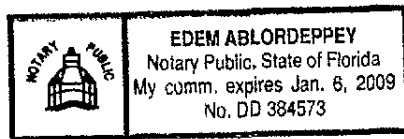

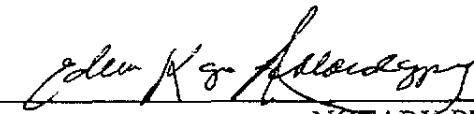

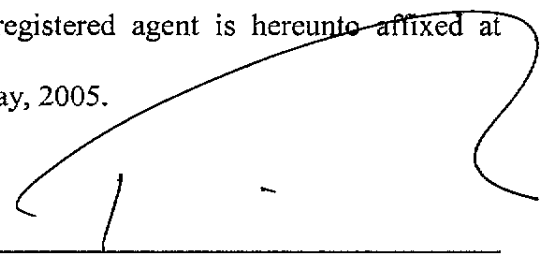
