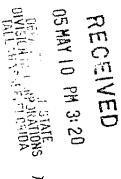

ARTICLES OF ORGANIZATION

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the State of Florida. the laws of the State of Florida.

The name of the Limited Liability Company ("Company") shall be JEBS, LLC.
