**ARTICLES OF ORGANIZATION**  
**OF**  
**FIRSTLINE JEWELRY PRODUCTS, LLC**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, does hereby adopt the following Articles of Organization:

**ARTICLE I**  
**Name**

The name of the Limited Liability company shall be Firstline Jewelry Products, LLC.

The name and street address of the initial Registered Office of the Limited Liability Company is Ted French, 2033 Main Street, Suite 304, Sarasota, FL 34237.



**ARTICLE VII**
