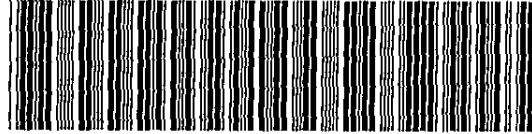

**ARTICLE I**  
(Name and Principal Place of Business)

**ARTICLE II**  
(Duration)



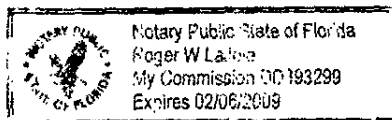


