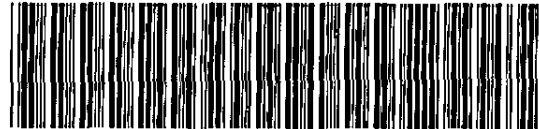



**ARTICLES OF ORGANIZATION OF
JMO ENTERPRISES OF FLORIDA, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "JMO ENTERPRISES OF FLORIDA, LLC."

ARTICLE II - Address

ARTICLE III - Duration


