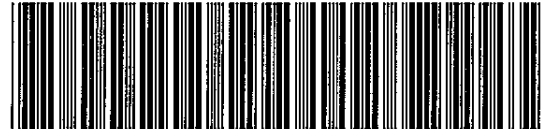

ARTICLE I - NAME

The regulations of this limited liability company may only be adopted, amended, altered or repealed by the unanimous vote of the members.


ARTICLE IX - MEMBERS' RIGHT TO CONTINUE BUSINESS
