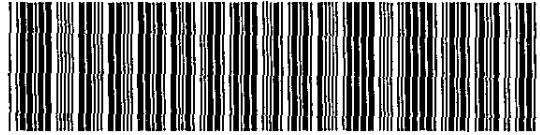

Article V


Admission of Additional Members


CERTIFICATE OF DESIGNATION OF
