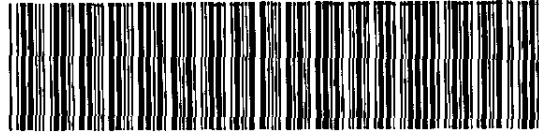

Name

The name of this Limited Liability Company is: EJW, LLC.

ARTICLE 2

Duration

The duration of this limited liability company is perpetual from the date of commencement of the limited liability company's existence.
