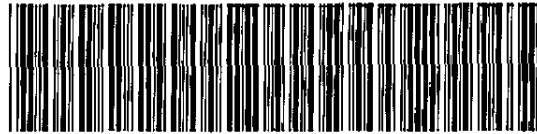

The undersigned individual, acting as the authorized representative of a member under provisions of Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name

The name of this Limited Liability Company shall be **MONTGOMERY HOLDINGS, L.L.C.**

Principal Place of Business and Mailing Address

Transfer of Member's Interest

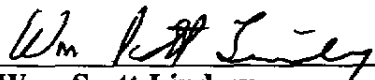

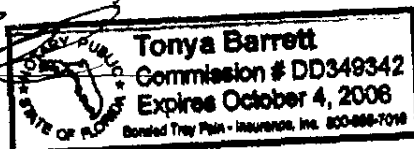

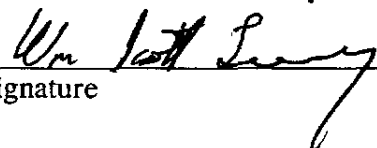
