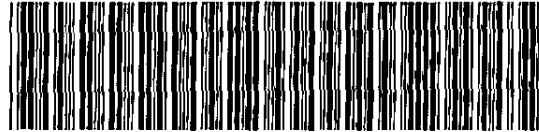

**ARTICLES OF ORGANIZATION
OF
C2G ENTERPRISES, L.L.C.**

**ARTICLE I
NAME**

The name of the Limited Liability Company is C2G Enterprises, L.L.C. (the "Company").

**ARTICLE II
ADDRESS**
